### **HANDLOADING FOR DEW USE (and otherwise too)**

Hand loading offers economy and optimisation of performance in your firearm if carried out correctly – so many of us do it.

Firstly, if members wish to use hand loaded ammunition on DEW controlled activities, individual prior DEW approval is mandatory, the process being as follows:

- Submit application to CWM on standard form (see website), which basically requires an indication of your loading experience and statement of your actual proposed loads for each calibre/projectile/propellant combination.
- CWM forwards the application to DEW who refer each application to their firearms referee.
- The DEW referee generally approves loads on the basis of propellant manufacturers' published minimum-maximum loading limits data for each calibre/projectile/propellant combination – the safety liability thus being with the loader and the propellant manufacturer.

Approved applications are then returned to the applicant via CWM.

Unfortunately, not all applications are approved, but are queried with the applicants through me, to check whether an error has occurred, or there is a question of competence, knowledge or exercise of caution which could result in unsafe and/or equipment damaging ammunition.

At this point, I would like to point out that the DEW referee is highly qualified and has a lifetime of practical experience (and experimentation) with military and hunting firearms, and any suggestions or comments he may make are worthy of consideration.

From several years of processing “queried” applications, I would suggest that applicants:

- Triple check all their submitted calibre/projectile/propellant figures.
- Make sure that your projectile is really equivalent to the one listed in the propellant manual.
- If you want to go outside the manual min/max limits – DON'T (and do not submit!)
- Discuss any queries before applying.

### **Feral deer at record numbers in South Australia & potential invasion coming to NSW suburbs**

The feral deer problem has been in the media this week with stories highlighting the damage they cause both in South Australia and urban NSW.

According to Primary Industries and Regions South Australia (PIRSA), there are now about 10,000 feral deer in South Australia — the highest number the state has seen.

The SA Government has introduced a new feral deer policy that requires landholders to completely destroy all feral deer on their properties.

However according to the Invasive Species Council, the issue is coming to the suburbs too, with deer causing car crashes and near misses and putting public safety at risk.

This is why our Centre, along with its members and partners has invested more than \$8.7 million (cash and in kind) to set up Australia's largest deer management research collaboration to ensure we have the best strategies to manage deer into the future.

*Cull reports inform us that much of our mid north is in drought and feral goats are in poor condition as are other herbivores.*

Vulkathunha Gammon Ranges cull 28/4 to 4/May: "Observations by all attending members indicated an overall dry and dire situation in the park. Carcasses of native animals were widespread with a lack of food being the apparent cause of death as water is available in various locations."



Kym McKenney's image of a soak in the Gammon-Vulkathunha Ranges shows us that drought has always been, and is, a part of life in SA, particularly beyond the Goyder rainfall the line. The Goyder line was said to divide the "hopeless farmlands from the merely heartbreaking."

Simon Nasht in his "The Last Explorer-Hubert Wilkins Australia's Unknown Hero" speaks of the conditions experienced by those pioneers who settled the north of this state.

*"Of all Australia's periodic dry spells, none was more catastrophic than the "Federation Drought" of 1901. Rivers Dried up and half the entire stock of sheep and cattle perished. In the cities they feared the taps might stop flowing, and just weeks after it had been celebrating nationhood, the government declared a "Day of Humiliation and Prayer". God turned a deaf ear.*

*At Mt Bryan East, where the dry came earlier and hit harder, the settler farmers hung grimly to the edge of the barren plains that seemed eager to be rid of them. Their stock grew progressively thinner and weaker, bleating and moaning through the scorched days and sweltering nights, the soil turned to dust by their desperate clawing for roots.*

*Back then, before the age of bulldozers, the bodies were left to rot where they fell. Death on this scale, with the terrible stench of rotting carcasses and the plague of flies that followed, left a deep impression on young George. In later life he referred to these years of misery "as the most depressing of any that I have experienced. Instead of spending my days at high school or college as I hoped, I was doomed to herd the starving animals and to rescue them from the mud of the waterholes. But they died in spite of all we could do. I can still shudder at the thought of these conditions...It was a terrible thing for an impressionable child to experience.'*
